

## Lane County Parks Special Use Permit Application

Special Use Permits (SUP) shall be obtained prior to conducting activity contrary to or not described by the Park Rules. Examples include but are not limited to: drone use, fire wood harvesting, geo-caching, scientific research and small events with fewer than 1000 attendees (for events with 1000+ attendees use the Special EVENT Permit Application. For SHELTER rental, reservations shall be made through the Lane County Reservation site).

**INSTRUCTIONS:** Complete and return the Special Use Permit Application in advance of the proposed event or activity. Park Staff will respond to approve, deny or request additional information and to provide notification of additional conditions for approval. The SUP holder agrees to comply with all park rules and all Conditions of Approval listed below. Approved permits shall be kept on-site for the duration of the event.

PARKING: An authorized SUP does not include parking. All vehicles shall display a valid parking pass. Day use passes are available for purchase in advance of your event on-line or by contacting the call center 541-682-2000.

Standard site availability is 10:00 am, however earlier access may be approved upon request.

NOTICE: Oregon law (ORS 105.682, et seq.) provides the owner of land is not liable in contract or tort for injury, death, or property damage that arises out of use of the land for recreational purposes (known as "recreational use immunity"). That immunity from liability does not apply if the owner makes a charge for permission to use the land. This fee is only for the use of the park for those activities directly related to the event identified on the Special Use Permit Application by the permit holder. Other uses of this park, or any use of the property outside of designated event area are not subject to a charge and, therefore, Lane County and the U.S. Government are not liable for injuries, death, or property damage arising out of such uses of the property for which no specific charge has been made. The permit holder agrees to comply with all Lane County park Rules and to all other terms and conditions of the actual permit. This includes, but is not limited to reimbursement for any damage to County real or personal property that occurs as a result of the event identified on the Special Use Permit Application by the permit holder.
