5. COUNTY ADMINISTRATION

a. Announcements.

Van Vactor stated that John Goodson was present to address the issue raised by Rust regarding the department of Public Works' employee recognition dinner this Saturday night.

John Goodson gave a brief summary of the recognition dinner and casino night.

Rust believed the department was sending an inappropriate message to the public because even though the recognition dinner would be separated financially, it was still under the county name. He acknowledged that Goodson had answered many of his original questions regarding the event; however, he was still not comfortable with the idea of casino night.

Goodson explained that everyone attending casino night would be given script for use in the games and, at the end of the evening, those people with the most script would be involved in a raffle for prizes. He noted that these prizes came from donations from the Public Works' Employees Association, which have fundraisers throughout the year, or from the \$5.00 entry fee for guests. Goodson noted that the prizes and all of the events related to casino night did not involve public funds.

Dumdi stated that there are a number of service organizations and churches that have this type of event regularly.

Goodson said the department debated how this would look and worked with the finance manager to make sure it was completely legal and ethical before going forward with it.

Green stated that he had no problem with the event and, if it created a level of interest from employees, he would support it. He did not want to send out the wrong message to employees by canceling it.

Weeldreyer agreed with Green and said she does not oppose it because she supports the good work that occurs in the Public Works department.

Green acknowledged that Rust is on record as not in support of casino night. He stated, however, that there was not majority Board support to direct cancellation of the event.

3. COMMISSIONERS' ANNOUNCEMENTS

Rust apologized for being defensive last week when they discussed the solid waste fees. He believed the figures discussed had about a 5-6 times disproportionate impact on 25% of the population. Rust asked that when they review this again, he would like a chance to weigh those figures more carefully.


Weeldreyer said she met with the Solid Waste Executive Group regarding a proposal for a possible restructure of the Solid Waste Management Team. She asked for Board consensus to allow that group to come back one more time and work with the management of the Solid Waste department.

Rust stated that as a member of the group, he was agreeable to that meeting with the provision that Craig Starr be allowed to put his plan on the table first to compare and analyze.

Green stated that there was support for the group to reconvene and bring back a report.

Dumdi commented that she is the board liaison to the Psychiatric Hospital Advisory Committee and should be added to the committee assignment list.

There being no further business, this meeting adjourned at 11:48 into executive session.
