WHEREAS, several Lane County departments require portable toilet rentals and service; and

WHEREAS, it is in the best interest of Lane County to issue a single contract for provision of the County's portable toilet needs; and

WHEREAS, the Parks Division solicited bids for portable toilet rentals and service for the period of April 1, 1996 through March 31, 1999; and

WHEREAS, the Parks Division received four sealed bids by the bid deadline of 10:00 am, on January 29, 1996; and

WHEREAS, all bids were opened and accepted by Bob Keefer, Parks Manager, and the Parks Division recommends that Lane County enter into a contract with Royal Flush Septic Service; now therefore be it

ORDERED that Royal Flush Septic Service be awarded a contract to provide portable toilet rentals and service for Lane County, as specified in the bid document; and it is further

ORDERED that the County Administrator be delegated authority to sign the contract.
