) IN THE MATTER OF ADOPTING) AN AMENDMENT TO THE RURAL) COMPREHENSIVE PLAN FOR THE) PURPOSE OF RELOCATING THE) NOTI-VENETA SECTION OF THE) FLORENCE-EUGENE HIGHWAY) ROUTE 126 AND TAKING AN) EXCEPTION TO STATEWIDE) PLANNING GOALS 3 & 4

WHEREAS, Lane County has received a request from the Oregon Department of Transportation to amend the Lane County Rural Comprehensive Plan, and

WHEREAS, Lane County, on the behalf of ODOT, has initiated this proposed amendment, and

WHEREAS, to approve the proposed amendment it is necessary that an exception to Statewide Planning Goals 3 and 4 be taken for lands designated in the Rural Comprehensive Plan as Forest or Agriculture and included in Official Plan Maps: 136, 141, 142, 149, 157, 167, and 177; and

WHEREAS, the Board of County Commissioners has received from the Lane County Planning Commission a recommendation for approval of the proposed amendment (the Planning Commission having heard this request at public hearings on 12/12/84 and 1/22/85), and

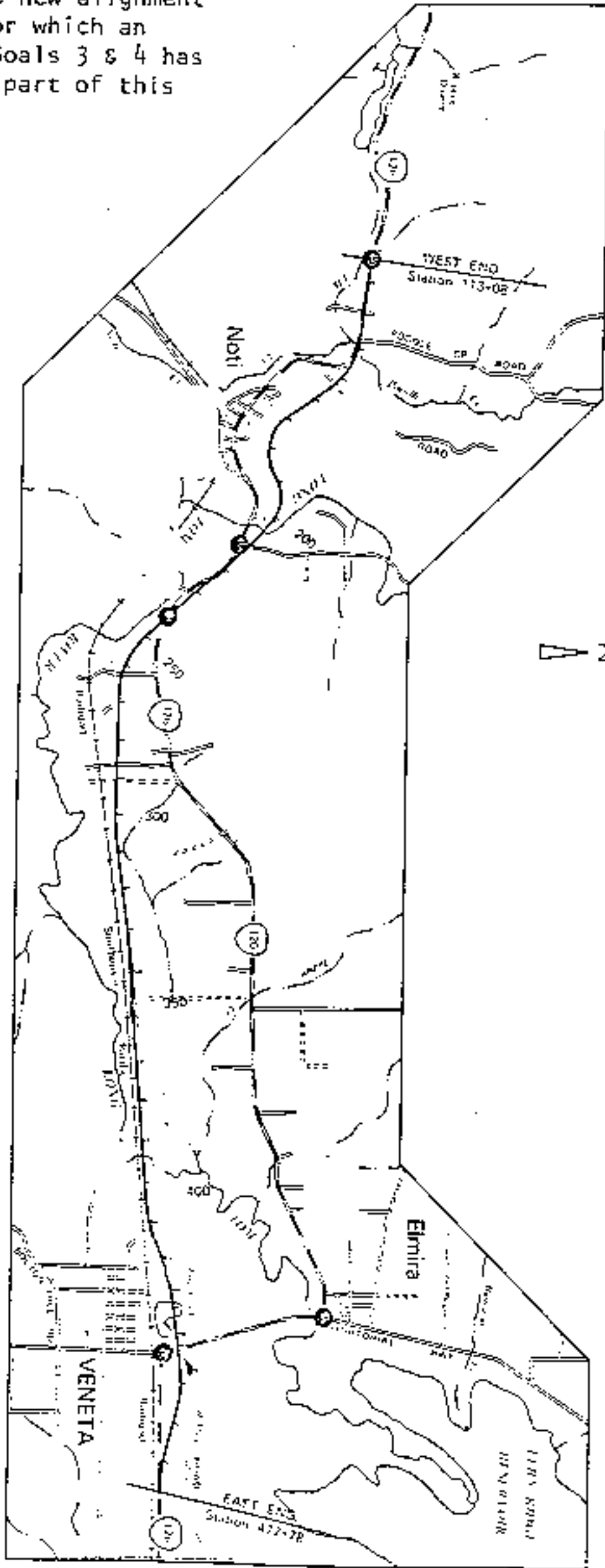
WHEREAS, the Board of County Commissioners has received and considered the proposed amendment to the Rural Comprehensive Plan at its public hearing and is ready to take action, now

THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF LANE COUNTY ORDAINS AS FOLLOWS:

- 1) The Rural Comprehensive Plan is amended to include the exception to Statewide Goals 3 and 4 for the relocation of the Noti-Veneta Section of the Florence-Eugene Highway Route 126 as described in the attached Exhibit "A".
2) If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.

While not part of this Ordinance, the Board of County Commissioners adopt the Legislative Findings set forth in attached Exhibit "B" in support of this action. It is also intended that the following documents on file in the Land Management Division of the Lane County Department of Public


- EXISTING HIGHWAY
