License Rei Mailed out letters advising dog owners their existing license and/or rabies is expired, or will expire within 30 days

RTO Return to owner Ex: picked-up a dog running loose and returned home to owner without having to impound

Bites Code required report of a bite resulting in skin breakage. Some may include a dispatch call for a Dangerous Behavior complaint.

DB New Dangerous Behavior, new formal complaints processed/citation issued

Voucher Approved and processed, not necessarily used

Voucher Used, submitted for payment to LCAS (from Vet)

Impounds Includes DOA's (dead on arrival)

PR Public relations. An informal request for contact to 'talk' to a citizen about an issue. Complainant doesn't want a ticket issued.
