As to the question presented, my honest answer would have to be "no," that the Court is probably not sufficiently budgeted. This is because I believe there is a large backlog of filings that people have been waiting to file, but have not been able to. We were unable to hold court for approximately five months in 2020, and even once we started up again holding in-person proceedings with COVID precautions, limitations and spacing, we were (and are) subject to filing moratoriums on a major segment of the cases we handle. I am referring here to eviction (FED) cases. I think it is also fair to say that there are many small claims civil cases that folks have been holding back on filing because of COVID safety concerns and the fact that physical access to the Justice Center is still limited. Further, our Failure to Appear rate on traffic violations has gone through the roof, resulting in the Court sending out many more letters to Defendants informing people that their drivers licenses will be suspended unless they appear in court to enter into payment plans. This has expanded our traffic docket, and will continue to do so, thereby further squeezing available court time for all types of cases. These circumstances have further motivated me in the direction of a mediation option I had already begun exploring. Since March of last year, the beginning of the COVID period, mediation agencies around the state began to explore remote options for conducting mediations. A few, such as Neighbor to Neighbor (N2N) Mediation in Salem, have been developing, fine-tuning, performing and perfecting the efficacy of that process for some time now. I have had a working relationship with N2N for several years as an occasional mediator, and I have had discussions with the Neighbor to Neighbor director about the possibility of N2N mediators obing remote mediation for ou
