



FY 20-21 In Review

COVID-19 Pandemic Impacts

- As of this writing, Lane County Circuit Court has not returned to prepandemic operations. We have over 2,500 pending cases from 2019 to present.
- The Death Investigations division was impacted financially due to the increase of supplies required as well as cost. For suspected COVID deaths outside of the hospital, jurisdiction was assumed in order to perform a postmortem COVID swab. In turn that increased the number of deaths under our jurisdiction, requiring a more lengthy investigation process. The impact of investigating additional deaths created a backlog of work, and many more hours worked than the expected 40 hour week by investigators.
- COVID-19 restrictions required modifications to the restraining order clinic and services provided by the Victim/Witness program. While paid staff continued to provide all mandated services, volunteers were sent home March 23, 2020 and returned mid-April 2021, resulting in a loss of over 4,500 volunteer hours in the office providing services to crime victims.



FY 20-21 In Review

COVID-19 Pandemic Impacts

- Family Law, despite court hearings that were limited or unavailable during most of 2020, collected almost \$21 million in child support payments to Lane County families. Court limitations on the issuance of bench warrants required investigator time to serve an increased number of citations for court proceedings.
- Prosecution Clerical Support was impacted by the physical limitations of the workplace, and the inability to safely practice social distancing. Staff were placed on an alternating schedule to reduce staff in the workplace and those whose job duties allowed, were set up for teleworking. Modifications were made to workstations to provide physical distancing and once the County moved to moderate risk, all staff returned to the office. Work slowed to an unacceptable level.
- Office lobbies in all divisions were closed at noon during High and Extreme Risk conditions, remaining accessible to the public by telephone.



FY 20-21 In Review

Holiday Farm Fire Impacts

The Holiday Farm Fire impacted Death Investigations in an abrupt and intense way. While continuing to work through the challenges of the pandemic, the fire immediately required a full-time investigator to be removed from the schedule and assigned to work directly with the Lane County Sheriff's Office and Search & Rescue. The Lead Investigator and Search and Rescue Coordinator created a county wide system of the recovery of remains. This assignment lasted two weeks and significantly impacted the workload of the other investigators.



Criminal Division

Mission: Investigate and prosecute violations of Oregon criminal statutes, and assist the Juvenile court.

- Teams: Major Crimes, Domestic Violence, 2 General Felony & Misdemeanor; one attorney assigned to juvenile; one attorney assigned to treatment courts (Drug, Veteran, Mental Health).
- Three investigators and six attorneys on call to assist law enforcement.
- Other statutorily required tasks outside of prosecution include public records appeals, expungements, and motions regarding sex offender registration requirements and license reinstatement.
- Mandated recording of Grand Jury proceedings began July 1, 2019, with no reimbursement from the State for attorney time to review transcripts in preparation of trial, protective orders, or paralegal time to process recordings and provide discovery. The State will cover the cost of transcripts with a contracted service.

Family Law Division

Mission: Enforce child support and health care coverage orders, establish paternity, establish new child support and health care coverage orders, and modify existing support orders in conformance with the Oregon Child Support Guidelines. The Division provides these services in compliance with Federal and State statutes and regulations.

- Secures appropriate support for children and families.
- Works to increase parent compliance with health care coverage orders for children.
- Funded by a Federal grant passed to us by the Oregon Department of Justice, which reimburses 66% of the costs of providing Child Support Enforcement

Support Services Division

- Mission: Provide comprehensive services to crime victims in order to guarantee that victims' constitutional and statutory rights are upheld; investigate unattended or non-natural deaths that are required by ORS Chapter 146; and provide clerical support to criminal division attorneys.
- Victim/Witness Program provides victim notification; restitution investigation and documentation; assisting victims filing for protective orders; referring victims to other community agencies; counseling referral as appropriate; assisting victims with filing claims with the State of Oregon Crime Victims' Compensation program, and providing culturally appropriate support through the criminal justice process.
- Death Investigations include apparent homicides, suicides, accidents, unattended deaths or those under suspicious or unknown circumstances; determining the cause and manner of death. The division also investigates found bones; determining if they are human versus non-human, determining identity and establishing the cause and manner of death with three FTE investigators and extra help.
- Prosecution Clerical staff provide assistance with case management, dockets, court filings, discovery, and records management.
