The Supervision unit is tasked with providing preadjudication, diversion and probation services for youth referred to the juvenile justice system by law enforcement. Juvenile Counselors working in the Supervision unit assess youth, provide a continuum of diversion services, prepare reports for the Court, supervise formal probation, present and testify at court hearings, implement cognitive behavioral individual and group interventions, supervise youth court-ordered to residential treatment programs, staff the Juvenile Drug Court program (RAP Court), and ensure culturally appropriate service delivery for youth and their families. Juvenile Justice Specialist provide diversion services and maintain custody of detained youth during court appearances. The Victim Advocate position and Division reception services are also housed in the Supervision unit.
