



During the last budget season we were able to make some changes:

 <u>Added 1 Parole and Probation Officer to the Jail / Sherman</u> <u>Center (Transition Officer)</u> – Goal is to fill this position by September 2017. We should see an increase in communication with offenders early on with the intent to have noticeable impacts to their success with treatment

Groundbreaking & Opening of Oaks @ 14th Our P&P Training Team was asked to speak at National Conference (APPA)










# P&P Budget by Fund

## **Overall Budget**






## **Overall Budget**

#### Total Budget: \$10,798,335





#### STAFFING: Need additional staff to meet current & future workload:

- Current caseload numbers exceed staffs ability supervise effectively.
- In comparison, Lane County supervises higher risk clientele which requires more resources.
- District Attorney's Office has increased prosecution which has resulted in increased caseload sizes.

# **Challenges Ahead**

#### Space Needs:

Main Office currently located on the 2<sup>nd</sup> Floor of the LCSO Community Corrections Center.

Current location has space for 33 Staff. P&P has 53, which has resulted in finding and assigning personnel to multiple outstations.

The current space originally designed as part of the Community Correction Center does not effectively meet our needs or operational requirements.


