ORDER NO. 17-05-16-04

IN THE MATTER OF FILING A LIST OF FY 17/18 PUBLIC IMPROVEMENT PROJECTS FOR LANE COUNTY PUBLIC WORKS DEPARTMENT WITH THE COMMISSIONER OF THE BUREAU OF LABOR AND INDUSTRIES (BOLI) AND DELEGATING AUTHORITY TO THE COUNTY ADMINISTRATOR TO EXECUTE RELATED CONTRACTS AND AGREEMENTS

**WHEREAS**, ORS 279C.305 requires that not less than thirty (30) days prior to the adoption of a budget, each public agency must: (1) Prepare and file with the Commissioner of the Bureau of Labor and Industries a list of each public improvement known to the agency that it plans to fund during the budget period (2) Identify each improvement by name and estimate of total on-site construction costs; and (3) List whether that project is to be bid out to a private contractor; and

**WHEREAS**, projects estimated to cost more than \$125,000 will conform to the requirements of ORS 279C.305 and will be constructed at the least cost to the public agency; and

**WHEREAS**, projects shown on the list of public improvements, attached hereto as Exhibit 'A', has been proposed by the Lane County Public Works Department for funding during FY 17/18; and


**WHEREAS**, each project to be funded must be included in an adopted Capital Improvement Program and/or identified in the FY 17/18 budget; and

**WHEREAS**, inclusion of a project in the list of public improvements (Exhibit 'A') does not obligate the County to fund that project in FY 17/18; and

**NOW, THEREFORE**, the Board of County Commissioners of Lane County **ORDERS** as follows:

1. That the list of FY 17/18 public improvements attached hereto as Exhibit 'A' be filed with the Commissioner of the Bureau of Labor and Industries in compliance with ORS 279C.305.
