IN THE MATTER OF DELEGATING AUTHORITY TO THE COUNTY ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH SUMTOTAL SYSTEMS, LLC & OPENSESAME, LLC TO PROVIDE LEARNING AND DEVELOPMENT CONTENT THROUGH LANE COUNTY'S LEARNING MANAGEMENT SYSTEM.

WHEREAS, Lane County Human Resources initiated a competitive process to renew/ select a replacement Learning Management System provider for the County; and

WHEREAS, Lane County conducted a comprehensive and competitive Request for Proposal (RFP) process where SumTotal, Systems .L.L.C. was the highest scoring proposal; and

WHEREAS, OpenSesame, LLC is a well-respected and leading course content provider that integrates with SumTotal, Systems L.L.C.; and

WHEREAS, the Board of County Commissioners must approve any contract that exceeds 3 years in term; and

WHEREAS, the Board of County Commissioners must approve any contract that exceeds \$100,000;

NOW, **THEREFORE**, the Board of County Commissioners of Lane County **ORDERS** as follows:

1. That the County Administrator be delegated authority to enter into a five year agreement with SumTotal Systems, L.L.C. & OpenSesame L.L.C. and be authorized to execute the contract, in the form attached as Attachment A, on behalf of the County.

Governing Law and Venue. This Agreement and all disputes hereunder, and the rights and obligations of the parties hereto, shall be governed by and construed in accordance with the laws of the State of Delaware without reference to its conflicts or choice of law provisions. All claims, disputes and/or lawsuits in connection with this Agreement shall be brought in the courts of the State of Delaware, and each party to this Agreement hereby irrevocably submits to the jurisdiction and venue of such courts.

Modification(s) to the Agreement. The following revisions to the Agreement are hereby made pursuant to Section 10.16 of the Agreement:

a. Section 4.3 of the Agreement is replaced with the following;

<u>Taxes.</u> The Commitment Fee and any other amounts payable to SumTotal hereunder are exclusive of taxes. SumTotal shall be responsible for all taxes payable in connection with its provision of the Service and Service Deliverables to Customer and on its income therefrom. SumTotal shall invoice Customer and Customer shall be responsible for all value-added, sales, service, or similar taxes payable in connection with its receipt and use of the Service and Service Deliverables under this Agreement. In the event that Customer is legally required to withhold income tax from any payments to SumTotal under this Agreement, SumTotal shall provide Customer with a valid tax residency certification as required under any double taxation treaty then in effect to reduce or eliminate the income tax to be withheld from these payments. Customer shall withhold tax at the applicable rate in effect as of the date of payment and shall provide to SumTotal on a timely basis documentation evidencing payment of the tax withheld to the applicable tax authority.

RATIFICATION. The terms and conditions of the Agreement shall govern the use of the Service provided hereunder. Any capitalized term not defined in this Order Form shall be defined as set forth in the Agreement.

The authorized representatives of SumTotal and Customer have executed this Order Form signifying their agreement to its contents.
