

BEFORE THE BOARD OF COMMISSIONERS OF LANE COUNTY, OREGON

ORDER NO: 22-08-23-06

In the Matter of Awarding \$3 million in American Rescue Plan Funds for Community Grants and Delegating Authority to the County Administrator to Execute the Contracts and Other Documents.

WHEREAS, the American Rescue Plan Act of 2021 (Public Law 11-2) also called the COVID-19 Stimulus Package or American Rescue Plan (ARP) Act, was passed by the 117th United States Congress and signed into law by President Joe Biden on March 11, 2021; and

WHEREAS, the ARPA provides for \$65.1 billion in direct allocation to counties. Lane County has received of \$74,212,036 in total; and

WHEREAS, ARP funds in the amount of \$54,878,000 were allocated to projects in Board Order 21-12-14-08 and \$9,949,000 were allocated to projects in Board Order 22-03-29-14 and \$165,000 were allocated in Board Order 22-06-21-15,

WHEREAS, the Board of County Commissioners directed staff to develop a community grant-making process whereby community based nonprofits and local governments could receive ARP funds to assist in the economic recovery from COVID-19,

NOW, THEREFORE, the Board of County Commissioners of Lane County **ORDERS** as follows:

1. American Rescue Plan funds of \$3 million are allocated to the following projects:
