

MEMBERSHIP TERM:	Initial Commissioner appointed members will serve a one (1) year term with the opportunity to reapply for two (2) additional two (2) year terms. Thereafter, two (2) year terms with the opportunity to reapply for one (1) additional term. The five (5) at large members will serve two (2) years with the opportunity to reapply for an additional two (2) year term.
LIAISON:	One (1) member of the Lane County Board of Commissioners will be appointed as a liaison to this committee.
