IN THE MATTER OF APPROVING

WHEREAS, the Public Health Advisory Committee has a vacancy as the result of resignation by the incumbent to healthcare professional position 11; and

WHEREAS, Committee recruitment resulted in the receipt and consideration of six applications, two from active practitioners (healthcare), eligible to encumber position 11.
