IN THE MATTER OF THE SURRENDER OF SOUTH 6TH STREET, COUNTY ROAD NO. 538, TO THE CITY OF COTTAGE GROVE WITH A PUBLIC HEARING. (21-03-04-21, 21-03-04-24).

WHEREAS, the City of Cottage Grove, pursuant to Resolution 2090, dated February 13, 2023, has requested Lane County surrender jurisdiction of an annexed portion of South 6th Street to the City of Cottage Grove; and

WHEREAS, ORS 373.270 provides for the surrender and transfer of jurisdiction over County Roads within a City, the County may transfer jurisdiction over County Roads or parts thereof within a City when it is considered to be necessary, expedient, or in the best interest of the County to do so; and the governing body of the City deems it necessary or expedient and in the best interest of the City to acquire jurisdiction over the County Roads or portions thereof and to the same extent as it has over public streets and alleys of the City; and

WHEREAS, the Board of County Commissioners approved Order Number 23-03-21-08 setting April 25, 2023 at 1:30 p.m. to conduct a Public Hearing on the matter of the surrender of South 6th Street, as described in Exhibit "A," to the City of Cottage Grove; and

**WHEREAS**, the Board of County Commissioners held a Public Hearing on the aforementioned time and date to allow public testimony for consideration, prior to approving or denying these proceedings; and

**WHEREAS,** notice of the Public Hearing was posted in six conspicuous places along the road in accordance with procedures outlined in ORS 373.270; and

WHEREAS, the Public Works Director of Lane County has favorably recommended that South 6th Street be surrendered to the City of Cottage Grove; and

NOW, THEREFORE, the Board of Commissioners of Lane County ORDERS as follows:

1. Lane County, in accordance with ORS 373.270, hereby surrenders jurisdiction of South 6th Street, as described in Exhibit "A," to the City of Cottage Grove.
