IN THE MATTER OF AWARDING A CONTRACT IN THE AMOUNT OF \$728,137.00 TO BRIDGEWAY CONTRACTING, LLC FOR REMODELING THE GROUND FLOOR LOBBY, ADMINISTRATIVE OPEN OFFICES, AND COMMUNITY ROOM AREAS AT LANE COUNTY BEHAVIORAL HEALTH, AND DELEGATING AUTHORITY TO THE COUNTY ADMINISTRATOR TO EXECUTE THE CONTRACT.

**WHEREAS,** the existing main lobby and entry areas at Behavioral Health are aesthetically and functionally outdated, lack proper lighting, and have limited sight lines for staff observing clients and general public occupants within the facility; and

WHEREAS, the existing lobby area lacks a trauma-informed setting for clients; and

**WHEREAS**, the project will add safety and security elements to the benefit of County staff, Providers, and clients; and

**WHEREAS**, the funding for improving these interior spaces is provided by a federal American Rescue Plan Act (ARPA) grant, administered via the Health Resources and Services Administration (HRSA); and

**WHEREAS**, the Department Manager has reviewed and approved this project and its funding source;

**NOW, THEREFORE**, the Board of County Commissioners of Lane County **ORDERS** as follows:

- **1.** The Lane County Behavioral Health Lobby Upgrade Project is approved for funding and construction.
- **2.** The County Administrator is granted authority to execute all contracts relative to this project.
