In the Matter of Adopting the 2023 Lane  
County Multi-Jurisdictional Natural Hazards  
Mitigation Plan

**WHEREAS**, the Board of Commissioners are committed to their strategic goals of a safe, healthy county, vibrant communities and robust infrastructure and the Board of Commissioners recognize that a commitment to disaster mitigation helps to achieve their strategic goals; and

**WHEREAS**, Lane County's Multi-Jurisdictional Natural Hazards Mitigation Plan (Plan) provides a road map for ongoing, comprehensive hazard awareness and mitigation and must be updated every five years; and

**WHEREAS**, the 2023-2028 Plan has been expanded to include the cities of Coburg, Creswell, Dunes City, Florence, Lowell, Oakridge, Veneta, and Westfir, along with the utilities Blachly-Lane Electric Cooperative, Consumers Power, Inc., and the Emerald People's Utility District (EPUD) making the Plan multi-jurisdictional; and

**WHEREAS**, the Plan must be updated and adopted by the local governing bodies of the communities participating in the Plan to remain eligible for Hazard Mitigation Assistance funding through FEMA; and

**WHEREAS**, the Oregon Department of Emergency Management and Federal Emergency Management Agency, Region X, officials have reviewed the Lane County Multi-Jurisdictional Natural Hazards Mitigation Plan (dated June 2023) and pre-approved it (dated September 2023) contingent upon this official adoption of the participating governments and entities; and


**WHEREAS**, the Board of Commissioners has reviewed the draft of Lane County's Multi-Jurisdictional Natural Hazards Mitigation Plan and found that the Plan reflects the intent of the Disaster Mitigation Act of 2000.

**NOW, THEREFORE**, the Board of County Commissioners of Lane County **ORDERS and RESOLVES** as follows:

1. Adoption of the Lane County Multi-Jurisdictional Natural Hazards Mitigation Plan, Version 4.0 (October 2023 – October 2028) that includes Lane County, City of Coburg, City of Creswell, City of Dunes City, City of Florence, City of Lowell, City of Oakridge, City of Veneta, City of Westfir, Blachly-Lane Electric Cooperative, Consumers Power, Inc., and the Emerald People's Utility District.
2. The Emergency Manager is delegated authority to approve minor administrative modifications to the Plan as requested by FEMA in order to receive final approval. The Emergency Manager is directed to report back to the Board with a summary of the administrative modifications made via email.

3. Lane County Emergency Management will submit this Adoption Resolution to the Oregon Department of Emergency Management and Federal Emergency Management Agency, Region X, officials to enable the Plan's final approval.
