IN THE MATTER OF ADDING TWO FULL-TIME (2.0 FTE) PHYSICIANS, ONE FULL-TIME (1.0 FTE) NURSE PRACTITIONER BILINGUAL, ONE FULL-TIME (1.0 FTE) MENTAL HEALTH SPECIALIST 2, ONE FULL-TIME (1.0 FTE) MEDICAL ASSISTANT 2 BILINGUAL, ONE FULL-TIME (1.0 FTE) MEDICAL ASSISTANT 2, ONE FULL-TIME (1.0 FTE) LICENSED PROFESSIONAL NURSE (LPN) BILINGUAL, ONE FULL-TIME (1.0 FTE) LICENSED PROFESSIONAL NURSE (LPN), ONE FULL-TIME (1.0 FTE) COMMUNITY HEALTH NURSE 2, ONE FULL TIME (1.0 FTE) OFFICE ASSISTANT 2 BILINGUAL, ONE FULL TIME (1.0 FTE) OFFICE ASSISTANT 2, ONE FULL-TIME (1.0 FTE) SENIOR OFFICE ASSISTANT, ONE FULL-TIME (1.0 FTE) PEER SUPPORT SPECIALIST, AND ONE FULL-TIME (1.0 FTE) COMMUNITY SERVICE WORKER BILINGUAL IN FUND 286 WITHIN THE DEPARTMENT OF HEALTH & HUMAN SERVICES TO STAFF THE NEW WALK-IN CLINIC AT 3321 W 11TH STREET, EUGENE, OR 97402.

WHEREAS, The recent closure of the University District Hospital and Urgent Care clinic on West 11th Avenue has resulted in a lack of options for non-appointment-based medical care; and

WHEREAS, The Community Health Centers of Lane County (CHCLC) has the opportunity to open a walk-in clinic in the building that formerly housed the West 11th Urgent Care location; and

WHEREAS, Provider and support personnel positions must be added in order to operate the walk-in CHCLC clinic; and

WHEREAS, the positions will be funded through program billing of the walk-in clinic; and

WHEREAS, appropriation of revenue and expense for the new positions will be made during the next supplemental budget process.

NOW, THEREFORE, the Board of County Commissioners of Lane County **ORDERS** as follows:


1. The total approved regular FTE for the fiscal year that began July 1, 2023, be increased as follows:
