In the Matter of Approving Three Public Works Contracts and Amendments and Delegating Authority to the County Administrator to Execute the Approved Contracts and Amendments for City of Eugene, Expense in the amount of \$940,000.00; R3 Consulting Group, Inc., Expense in the amount of \$40,000.00; Kendall Ford LLC dba Kendall Ford of Bend, Expense in the amount of \$185,000.00.

WHEREAS, Lane Manual Chapter 20 sets forth the County’s policies regarding award, acceptance, and amendment of grants and contracts; and

WHEREAS, all of the contracts or grants listed below have been accepted or award in accordance with the requirements of the Lane Manual, including the requirements for competitive selection; and

WHEREAS, all the projects and services covered by the contracts, amendments, and grants listed below are routine to the implementation of current County programs and services or have been previously discussed or approved by the Board; and

WHEREAS, these contracts, amendments, and grants exceed the County Administrator’s authority to execute granted in Lane Manual sections 20.600.220 to 20.600.320,

NOW, THEREFORE, the Board of County Commissioners of Lane County **ORDERS** as follows:

1. That the contract listed in Exhibit A – March 12, 2024, is approved and the County Administrator is delegated authority to sign the approved contract.

Description	This Intergovernmental Agreement between City of Eugene and County agrees that County will surrender jurisdiction over the county sections of the following roads: Irvington Drive from easterly end of that portion and extending easterly 500 feet to River Road; county road section of River Road from Rosewood Avenue extending southeasterly 745 feet to Maynard Avenue; county road section of River Road from Merry Lane extending southeasterly 1257 feet to Horn Lane; county road section of River Road from Wedgewood Drive extending northwesterly 8500 feet to the urban growth boundary; County agrees to provide funding toward future street improvements to be constructed by Eugene, in the amount of \$940,000 for the surrendered portion of River Road upon City of Eugene’s notification of its completion of acquisition of jurisdiction of all street segments; City of Eugene will assume maintenance responsibilities of all infrastructure within the right of way, including stormwater facilities, upon acquisition of jurisdiction of all street segments.
