ORDER NO. 24-03-19-02

IN THE MATTER OF SETTING A PUBLIC HEARING FOR THE SURRENDER OF SEVEN COUNTY ROADS OR PORTIONS THEREOF TO THE CITY OF EUGENE

WHEREAS, the City of Eugene, pursuant to Council Resolution 5400, dated February 14, 2024, has requested the jurisdiction over portions of seven County Roads be transferred to the City of Eugene; and

WHEREAS, the portions of County Roads herein proposed for surrender are those portions described in attached Exhibit "A;" and

WHEREAS, the County Roads herein proposed for surrender lie entirely within the city limits of Eugene; and

WHEREAS, ORS 373.270 provides for the surrender and transfer of jurisdiction over County Roads within a city, the County may transfer jurisdiction over County Roads or parts thereof within a City when it is considered to be necessary, expedient, or in the best interest of the County to do so; and the governing body of the City deems it necessary or expedient and in the best interest of the City to acquire jurisdiction over the County Roads or portions thereof and to the same extent as it has over public streets and alleys of the City; and

WHEREAS, ORS 373.270 requires the governing body to give notice either by posting or publishing the time and place of the public hearing the County governing body shall hear the matter, consider any objections or testimony offered by any person interested and determine whether it is necessary, expedient or for the best interests of the County to surrender jurisdiction over the County Road or portion thereof to the City; and

WHEREAS, the Public Works Director of Lane County has recommended a Public Hearing date be established to consider the offer of surrender to the City of Eugene the portions of seven County Roads as described in attached Exhibit "A;" and

WHEREAS, the Board is of the opinion that setting a date to hold a Public Hearing to consider the request to surrender the County Roads to the City of Eugene is in the best interest of the public; and

NOW, THEREFORE, the Board of Commissioners of Lane County **ORDERS** as follows:

- 1. A Public Hearing shall be held on <u>APRIL 30, 2024, AT 1:30 P.M.</u>, time certain, to formally consider the surrender of portions of the seven County Roads as described in Exhibit "A," attached and made a part of this Order, to the City of Eugene.
- 2. Legal notice of the Public Hearing be posted or published, in accordance with ORS 373.270.
- 3. The Director of the Lane County Department of Public Works to prepare and provide a Final Report on the proposed surrender.
