ORDER NO: 24-03-29-01

In the Matter of Clarifying the Boundaries of  
the Proposed Row River Rural Fire Protection  
District

**WHEREAS**, on August 10, 2023, a petition initiating the formation of the Row River Rural Fire Protection District was filed with Lane County, in accordance with ORS 198.750;

**WHEREAS**, on October 9, 2023, the County Clerk certified that the requisite number of voters signed the petition, in accordance with ORS 198.755(1)(a);

**WHEREAS**, on January 9, 2024, the Board of County Commissioners ordered that an election on the formation of the proposed District occur on May 21, 2024; and

**WHEREAS**, the description of the boundaries of the District incorporated in the Board of County Commissioners' January 9, 2024 order failed to accurately reflect the intentions of the Board of Commissioners and of the petitioners as stated in the Draft Ballot Language incorporated into the January 9, 2024 order;


**NOW, THEREFORE**, the Board of County Commissioners of Lane County **PROCLAIMS AND ORDERS** as follows:

1. The description of the boundaries of the District attached as Exhibit A to Board Order 24-01-09-27 is hereby superseded and replaced by the description of the boundaries of the District in **Exhibit A**, attached hereto.

2. The description attached hereto as **Exhibit A** may be revised or amended by the Oregon Department of Revenue only to the extent necessary to correct any errors or omissions that would render the description unfeasible or contrary to the Department's technical requirements.

3. No other portion or clause of Board Order 24-01-09-27 is revised, superseded, or otherwise disturbed by adoption of this Order.
