5-YEAR FUNDING MEASURE TO SUPPORT AND IMPROVE LANE COUNTY PARKS

Lane County's park system includes 4,364 acres of natural, recreational, and cultural assets at 68 sites spread across the County's 4,800 square miles. The County's parks and open spaces encompass ecosystems that support wildlife habitat, biodiversity, and clean air and water. County parks provide access to fishable, swimmable, and navigable rivers and include developed facilities such as campgrounds, RV sites, picnic areas, boat launches, and various trails. The Lane County Parks Division has operated on a budget of approximately \$4 million per year, of which 48 percent is user fees. Currently, there is no property tax funding. Lane County Parks Division is looking for additional, stable operational funding. Maintenance, development, and enhancement projects have been deferred requiring supplemental revenue to fulfill the Lane County Parks & Open Space Master Plan approved in December 2018.

The proposed local option levy is a five-year property tax. The median homeowner would pay approximately \$38 per year, based on \$0.16 per \$1000 of assessed value. The proposed measure would raise an estimated \$31 million to support maintenance and realize improvements at Lane County Parks as follows:

- **PARK INVESTMENTS & IMPROVEMENTS:** improve park amenities including restrooms & lockers, shelters, paving & curbs, boat ramps, trail signage, water, electric and sewer systems; add EV charging stations; update ADA accessibility transition plan and undertake improvements
- **MAINTENANCE & OPERATIONS:** add 10 additional full-time employees and supplies, including a grant writer to leverage funding to supplement fee-based revenue
- SPECIAL PROJECTS: undertake facility and trail improvements, cooperative improvement projects, and water access enhancements; hire a dedicated Sheriff's deputy to patrol Lane County parks and address safety and security concerns; assist with the development of a regional pickleball facility
- **CONSERVATION & EDUCATION:** perform riparian & floodplain restoration and invasive species removal; create educational and interpretive programming in habitat restoration, stewardship, recreation, and birding with community partners and volunteers

The proposed levy would fund improvements at many parks, including five large and wellvisited parks that are located in each region of the county:

- Armitage Park & Campground
- Baker Bay Park & Campground
- Buford Park & Mt. Pisgah
- North Jetty Park & Beach Access
- Richardson Park & Campground

Professional evaluation of the condition of Lane County's most used parks found \$21.9 million in deferred maintenance projects unaddressed due to limited funding. If these projects are not addressed the total will reach an estimated \$38.4 million within ten years. The proposed measure begins the process of addressing this deferred maintenance.

Restoration projects would be undertaken to preserve habitats, helping to improve water quality. It would fund the repair or replacement of aging restrooms and water systems that pose a risk of failure near bodies of water. Plus, camping and boating infrastructure at Fern Ridge Reservoir and along the McKenzie, Willamette, and Siuslaw rivers would be improved.

This measure would provide a dedicated revenue source for Lane County Parks over the next five years, and leverage partnerships, various grant opportunities, and volunteerism.



Lane County Parks Natural Areas Operations Report for March 2024

Ed Alverson, Natural Areas Coordinator

Ice Storm Recovery: March brought additional work in response to the January ice storm. I've been involved in efforts to address lingering storm clean-up needs with Vickery Park and Whitely Landing, as well as conversations with BPA about future repairs to trails in HBRA that were damaged by their equipment responding to down transmission lines.

HBRA Trails: Rebecca and I are working with Friends of Buford Park staff with the ongoing implementation of the Trail 3 East project, a which will be constructed to universal access standards. The project should be completed later this year.

Stakeholder Meetings: I facilitated the monthly HBRA stakeholder meeting and participated in a project meeting for the HBRA Waterway Access project.

Eagle Rock Park: Efforts are continuing to construct a covered shelter in Eagle Rock Park; Rebecca and I have been reviewing the LMD permitting requirements as the park design report is being completed by RTCA staff.

Armitage Park: I worked with Parks Maintenance staff to flag the areas of Armitage Park with shooting stars and other wildflowers so they can be left un-mowed during the spring. I've also been participating in the Armitage Park sewer and water project meetings.

Zumwalt Park Shoreline Stabilization: Walama Restoration has now installed of straw bales and willow stakes along the eroding shoreline on the east side of the park. The reservoir should reach full pool in mid-April, so it will be interesting to see how the plantings respond.

Parks Newsletter: I've written short articles for the Spring Parks Newsletter on the topics of boot brush stations at HBRA, prescribed burn habitat response, and tick season.

Sheriff's Work Crew: I was part of a group of Parks staff who met this month with Sheriff's Work Crew staff in an effort to initiate more regular assistance with Parks projects buy the SWC.

Project Planning and Coordination: I participated in several meetings coordinating rare plant recovery. One was the annual meeting of the Prairie Plant Working Group, another was a working group specifically focused on the recovery of the leafy peavine, *Lathyrus holochlorus*, which grows at HBRA. Rebecca and I participated in a meeting of Rivers to Ridges partners to assist Willamalane with scoping a planned slough restoration project in Island Park, Springfield
