I. MOTION

II. AGENDA ITEM SUMMARY

The Board is being asked to consider approving representatives, liaisons and designees to various agencies and committees for 2011.

III. BACKGROUND/IMPLICATIONS OF ACTION

A. <u>Board Action and Other History</u> Historically, the Board has appointed Commissioners to act as representatives and liaisons to various committees and agencies. The Board moved away from that practice in 2009 and instead appointed the County Administrator to act as it's representative for most of the various internal and external committees and agencies to which the Board has an opportunity to appoint commissioner representatives. This agenda item presents the Board with an opportunity to discuss a move back to the more historical approach of appointing Commissioners as a representative or liaison of the Board to each of the various committees or agencies that require or seek participation of the Board of Commissioners.</u>

B. <u>Board Goals</u> These appointments are consistent with many expressed goals, including the goal of improving relationships with partner agencies.

C. <u>Financial and/or Resource Considerations</u> Returning to the how these appointments have historically been made will relieve the Administrator of significant duties, allowing the County Administrator to focus on other issues.

D. <u>Analysis</u> The proposed orders, when filled in with names of Commissioners as representatives or liaisons to the various committees and agencies that require or seek Board involvement will accomplish the Board goals and will be consistent with the state laws or intergovernmental agreements that require participation of one or more Commissioner. Depending on the direction of the Board, conforming Lane Manual revisions will be prepared to reflect the level of Commissioner participation this Board would like to have in the various committees, districts or agencies. Copies of the orders adopted in 2008 and 2010 are attached to provide some comparison of the different approaches and examples of prior Board actions taken to appoint Commissioners or designates to the appropriate body.


