- 1 Humane Society Liaison

WHEREAS, the formation of an Advisory Task Force is supported by the Management Services Director and Animal Regulation Program Manager; and

WHEREAS, the Board has reviewed the recommendations and been fully advised; NOW THEREFORE BE IT

ORDERED, an Animal Regulation Advisory Task Force is hereby established with the charge of providing recommendations to the Board with regarding to licensing; spay & neuter; legal issues; public education; facility and staffing and funding for LCARA. The Task Force shall follow the procedures set forth in LM 3.507(1)(b). It shall consist of nine members as forth above and shall hold monthly meetings; and
