### I. MOTION

#### III. DISCUSSION

### A. Background

By Order 03-1-21-19 Cindy Weeldreyer was appointed by the Board of County Commissioners to represent Lane County on the Regional Fiber Consortium and the Fiber South Consortium boards of directors. The Economic Development Standing Committee recommends that this appointment be extended to December 31, 2003.

#### B. Analysis

The Board of Commissioners may appoint persons to represent the county on committees, as determined appropriate by the Board. Because of her experience and current status as Lane County's representative on the consortia boards, it is appropriate to extend this appointment for a four month period. This will help to ensure continuity in consortia business.

# C. Alternatives/Options

The Board may:

- 1) Approve the ORDER extending the appointment, or
- 2) Decide not to extend the appointment.

## D. Recommendations

Number 1 is recommended, to extend the appointment to December 31, 2003.

# E. Timing

The current appointment expires August 31, 2003.

Upon approval of the Board, the appointment will take immediate effect.
