**SUBJECT:** ORDER/IN THE MATTER OF AUTHORIZING THE SALE OF SURPLUS COUNTY OWNED REAL PROPERTY TO ROBERT H. HYLTON AND JO DE HYLTON FOR \$5,000 (MAP # 18-12-02-20-03500, ADJACENT TO 88551 HWY 101, FLORENCE)

- 1. **PROPOSED MOTION:** THE BOARD OF COUNTY COMMISSIONERS MOVES TO AUTHORIZE THE SALE OF SURPLUS COUNTY OWNED REAL PROPERTY TO ROBERT H. HYLTON AND JO DE HYLTON FOR \$5,000 (MAP # 18-12-02-20-03500, ADJACENT TO 88551 HWY 101, FLORENCE)
- 2. **ISSUE/PROBLEM:** Mr. and Mrs. Hylton have submitted an offer of \$5,000 for the subject property. The offer is being forwarded to the Board for consideration for acceptance.

### 3. **DISCUSSION:**

## 3.1 Background

The subject property is a 62' x 145' (.23 acre) unimproved parcel. The subject property was acquired through tax foreclosure in June 1976. The subject property is zoned R1. The parcel has an assessed value of \$18,142. The subject's size will make it difficult to site a well and septic system. The Hylton's own property adjoining the subject to the North.

The subject property was offered at the recent Sheriff's sale held on December 9, 2002 with a minimum bid of \$8,000. The subject property has been offered at a previous Sheriff sale in 1999 with a minimum bid of \$18,000. The parcel has been available for private sale after each Sheriff's sale.

## Analysis

As adjoining owners, the Hylton's may be able to develop the parcel with a dwelling by using their property for the septic system and well water. The subject can also provide additional plottage to their property if not developed. It would be difficult to develop or otherwise use the subject for someone other than an adjoining owner.

Pursuant to ORS 275.200, property that did not sell at a Sheriff's sale can be sold at private sale without further notice but for not less than 15% of its minimum bid at the Sheriff's sale. The \$5,000 offer meets the requirements of ORS 275.200.

# 3.3 Alternatives/Options

The Board can reject the Hylton's offer and direct staff to continue negotiations or offer the property at a future Sheriff's sale.

## 3.4 Recommendation

It is recommended that the offer of \$5,000 be accepted.

## 3.5 Timing

None.

4. **IMPLEMENTATION/FOLLOW-UP:** Upon approval by the Board of County Commissioners, the Quitclaim Deed will be executed and the property will be sold.
