AGENDA ITEM TITLE: IN THE MATTER OF VACATING A PORTION OF ROUSE ROAD, ALSO KNOWN AS BLACK BUTTE ROAD (COUNTY ROAD NUMBER 351), WITHOUT A PUBLIC HEARING, AND ADOPTING FINDINGS OF FACT (22-03-30-10)

## I. MOTION:

TO APPROVE THE ORDER VACATING A PORTION OF ROUSE ROAD, ALSO KNOWN AS BLACK BUTTE ROAD, (COUNTY ROAD NUMBER 351), LOCATED SOUTH OF COTTAGE GROVE NEAR THE INTERSECTION OF LONDON ROAD AND SHOESTRING ROAD, WITHOUT A PUBLIC HEARING, AND ADOPTING FINDINGS OF FACT (22-03-30-10)

#### II. ISSUE:

To decide whether a portion of County Road Number 351, being 30 feet wide, and approximately 148 feet in length, lying east of London Road, near the intersection of Shoestring Road, should be vacated as petitioned for.

# III. DISCUSSION:

#### A. Background:

The Surveyor's Office of the Department of Public Works has received a valid petition signed by Marco Giarrusso, Louise Giarrusso and Thomas Chrestman, landowners of 100% of the property abutting the proposed vacation of a portion of a Rouse Road. The petitioners are requesting, by the authority of ORS 368.351, a vacation without a public hearing.

County Road Number 351 was established as Rouse Road in July 1879, with a right of way width of 30 feet. Rouse Road was subsequently realigned and altered in 1961. The Alteration Order specifically reserved the northerly portion of County Road Number 351 from the realigned Black Butte Road, commonly known as London Road, to the westerly extension of the southerly line of Tax Lot 200 of Assessor's Map 22-03-30-10, in order to serve as an access for said tax lot.

The petitioners had originally made the request for this vacation in 1997, with intentions to adjust the property lines and transfer the small area of land between the realigned road and the old road, from the Chrestmans (Tax Lot 300) to the Giarrussos (Tax Lot 200). The staff at the Surveyor's Office asked that the property line adjustment be completed before the vacation request was submitted to the Board of Commissioners so that the Giarrusos would not loose legal access to a public road. The property line adjustment was completed in 1998, however the Surveyor's Office was not made aware of this until recently, and the petitioner did not realize that the vacation had not been completed. The Surveyor's Office is now finalizing the vacation process and will be presenting the Board of Commissioners with the request to vacate the portion of Rouse Road that lies within the bounds of the Giarrusso property (Tax Lot 200).

Qwest Communications, Emerald People's Utility District, Northwest Natural Gas, and various other agencies including Transportation Planning, and Lane County Planning sections of the Lane County Public Works Department, as well as area landowners, were contacted regarding the vacation in December, 1997, and again in December, 2002. The agencies and landowners had no objections or did not reply to either of the referrals.

#### B. Analysis:

If the proposed vacation is approved, it will allow for use of the property by the primary petitioners. The property line adjustment has been completed and recorded on Reel 2421R, Instrument Number 9839172, and the Giarrussos property now extends westerly to the realigned Black Butte Road (London Road) with the subject portion of Rouse Road running through their property.

There are no known utilities within the subject right of way, and no property will be denied legal access to a public road. The right-of-way proposed for vacation is not needed by the Lane County transportation system. The public interest will be served, as unneeded public right of way will be put to better use.

## C. Alternatives/Options:

The Board of County Commissioners has the options to:

- 1. Approve the vacation of the portion of Rouse Road (County Road Number 351) as petitioned for.
- 2. Deny the vacation of the portion of Rouse Road (County Road Number 351) as petitioned for.
- 3. Continue the matter for further consideration.
- 4. Direct that a public hearing be held for the proposed vacation and that staff contact the petitioners to see if they wish to proceed with this stipulation.

## D. Recommendations:

The Public Works Director's Report recommends that the Board support Option Number 1, approving the vacation of the portion of Rouse Road (County Road Number 351) as petitioned for. No property will be denied legal access by this vacation. The vacation is in the public's interest, as vacating this portion of the described right-of-way will allow it to revert back to private property and enable the landowners to more fully utilize their property.

All statutory procedures necessary for the vacation without a public hearing of the above mentioned right of way have been complied with, including a report by the Director of Public Works, who recommends approval of the vacation as described in the petition.

# E. Timing:

Timing is important, as the original request for the proposed vacation was made in 1997 and it would be beneficial to finalize the process and update the records.

# IV. IMPLEMENTATION/FOLLOW-UP:

If the Board of County Commissioners approves the Order of Vacation, it is to be forwarded to the Lane County Recorder for filing and recording, after which copies are to be forwarded to the County Surveyor and County Assessor for appropriate action. If the vacation is denied, an Order to Deny the Vacation will be presented to the Board at a later regularly scheduled meeting.

If the petitioners are given an option to proceed with a public hearing, they will have 180 days to decide whether or not to continue with the proposed vacation. If they decide to proceed with the proposed vacation the staff will prepare a Resolution and Order to set a date for a public hearing, but if the petitioners decide to terminate the proceedings, an Order to Deny will be presented to the Board at a later regularly scheduled meeting.

The Surveyor's Office of the Department of Public Works has received a valid petition signed by the owners of 100% of the property abutting the proposed vacation requesting, by the authority of ORS 368.351, a vacation without a public hearing.

County Road Number 351 was established as Rouse Road in July 1879, with a right of way width of 30 feet. Rouse Road was subsequently realigned and altered in 1961. The Alteration Order specifically reserved the northerly portion of County Road Number 351 from the realigned Black Butte Road, commonly known as London Road, to the westerly extension of the southerly line of Tax Lot 200 of Assessor's Map 22-03-30-10, in order to serve as an access for said tax lot.

Various public and private agencies and area landowners were contacted regarding the vacation in December, 1997, and again in December, 2002, and either had no objection or did not reply to the referral.

No property will be denied legal access by this vacation. The vacation would allow for use of the property by the property owners. The public interest will be served as unneeded public right-of-way will be put to better use.

It is therefore recommended, that the portion of County Road Number 351, as described in the Order, be vacated as petitioned for. It is further recommended that the vacation be allowed without a public hearing.

The Surveyor's Office of the Department of Public Works has received a valid petition, signed by the owners of 100% of the property abutting the proposed vacation, requesting that the portion of Rouse Road as described in the Order be vacated as petitioned for. The petitioners request the vacation in order that they can use the land more effectively. Due to a property line adjustment the portion of right of way proposed to be vacated is no longer needed as access.

#### Findings of Fact (Public Interest)

The Board takes notice and finds:

- 1. That, pursuant to ORS 368.326 and 368.366, a county governing body may vacate roads or right-of-way based upon the determination that the vacation is "in the public interest".
- 2. That, pursuant to ORS 197.175 (2) (d), after acknowledgment of a county's comprehensive plan and implementing ordinances, the plan and ordinances, not the Statewide Planning Goals, control land use decisions.
- That, Lane County's Rural Comprehensive Plan and implementing ordinances were originally acknowledged to be in compliance with the Statewide Planning Goals on September 13, 1984, and reacknowledged on February 14, 1992.
- 4. That, neither the Lane County Comprehensive Plan nor any land use regulation within the Lane Code establish mandatory standards for the vacation of streets and roads.

## Conclusion of Law (Public Interest)

Based upon the above findings of fact, the Board concludes, as a matter of law, that neither the Statewide Planning Goals nor the Lane County Rural Comprehensive Plan and related land use regulations are an applicable measure of the "public interest", as it pertains to this vacation.

## Findings of Fact (Impacts and Process of Vacation)

The Board takes notice and finds as follows:

- 1. That, the petitioners own all property abutting the proposed vacation. Said property is further identified as Tax Lots 200 & 300 of Assessor's Map 22-03-30-1.
- 2. That, the previously identified property is outside any city limits and therefore under the jurisdiction of Lane County.
- 3. That, the Emerald People's Utility District, Northwest Natural Gas, Qwest Communications, and various other agencies including Transportation Planning, and Lane County Planning sections of the Lane County Public Works Department, as well as area landowners, were contacted regarding the vacation and either had no objection or did not reply to the referral.
- 4. That, there are no known existing utilities within the right-of-way proposed for vacation.
- 5. That, vacating the portion of Rouse Road as described in the Order will not deny any landowners legal road access to a public road, provided the conveyance as discussed in the report from the Director of the Department of Public Works occurs.
  - 6. That, pursuant to ORS 368.351, a county governing body may make a determination about a vacation of property without a public hearing if:
    - (1) The county road official files a written report stating that the vacation is in the public interest.
    - (2) The proceedings were initiated by petition indicating the approval of 100% of the adjoining property owners.

Items (1) and (2) have been complied with.

#### Conclusions of Law (Impacts and Process of Vacation)

Based on the above findings of fact, the Board concludes, as a matter of law, that this vacation will not have any predictable negative impact on present or future land use, either in terms of allowable uses or actual development. The Board further concludes that statutory procedures necessary for making a determination on this vacation, without a public hearing, have been met.
