I. MOTION

(1) TO PHARMACEUTICAL SERVICES AGREEMENT BETWEEN CONTRACT
PHARMACY SERVICES, INC. AND LANE COUNTY.

ISSUE/PROBLEM

Should Lane County Board of Commissioners approve the County Administrators execution of Amendment No. One (1) to Pharmaceutical Services Agreement extending the contract an additional ninety (90) days.

II. DISCUSSION

A. Background

Board Order 00-9-13-10 approved the acceptance of bid, contract award to Contract Pharmacy Services, Inc. and execution of contract for inmate pharmaceutical services at the Lane County Adult Corrections Facility.

Agreement between Lane County and Contract Pharmacy Services began 17 October 2000 and ending 16 October 2003.

Amendment No. One (1) will begin 17 October 2003 and ending no later than 16 January 2004, an extension not to exceed 90 days.

Amendment No. One (1) increases the contract an amount not to exceed \$62,500. The additional \$62,500 falls within the amendment increase allowed by Lane Manual for County Administrator execution without Board Approval.

B. Analysis

Amendment No. One (1) is required due to the length of time it will take to receive and adequately evaluate the Requests for Proposal (RFP), and prepare a new contract to provide inmate pharmaceutical services to the Lane County Adult Corrections Facility.

C. Alternatives/Options

- 1. Adopt the Order to approve Amendment No. One (1) to Pharmaceutical Services Agreement.
- 2. Do not approve the order, resulting in no contract for inmate pharmacy services.

D. Recommendations

Recommends Board approval of proposed Board Order.

E. <u>Timing</u>

As stated above.

A new contract for inmate pharmacy services will be awarded following evaluation of the RFP.

PHARMACEUTICAL SERVICES AGREEMENT AMENDMENT 1

WHEREAS, Contract Pharmacy Services, Inc., a Pennsylvania corporation hereinafter referred to as CONTRACTOR, and Lane County, a political subdivision of the State of Oregon hereinafter referred to as COUNTY, entered into a pharmaceutical services agreement on 17 October 2000 for the purpose of providing inmate pharmacy services to the Lane County Adult Corrections Facility; and

WHEREAS, the agreement expires 16 October 2003; and

WHEREAS, there is a need for the continuation of assistance through 16 January 2004, and an increase in the contract amount not to exceed \$62,500.

NOW THEREFORE, the agreement is amended as follows:

- 1. COUNTY and CONTRACTOR agree to extension of the agreement until 16 January 2004.
- 2. The previous requirements contract (PO # 202135) total expense to date is approximately \$862,250; this amendment increases that by \$62,500, bringing the expected contract total to \$924,750.
- 3. All other provisions of the original contract not altered by this amendment shall remain in full force and effect.
