#### I. MOTION

MOVE TO AWARD A THREE YEAR REQUIREMENTS CONTRACT TO CASCADE HEALTH

SOLUTIONS FOR THE PURCHASE OF ALCOHOL AND DRUG TESTING,

CDL PHYSICALS, AND MISCELLANEOUS SERVICES

#### II. ISSUE OR PROBLEM

Shall Lane County approve awarding a three year requirements contract to Cascade Health Solutions for the purchase of alcohol and drug testing, CDL physicals, and miscellaneous services?

#### III. DISCUSSION

#### A. Background

Lane County Public Works began pre-employment and random drug and alcohol testing in January of 1995 to comply with Federal Highway Administration rules governing Commercial Drivers License employees. Currently the Department has about 160 employees involved in the mandatory testing program.

These services were initially provided by PeaceHealth. In October 1998, the Department issued a request for proposals (RFP), including legal advertisement in the Register-Guard. There were two responses to the RFP, PeaceHealth Occupational Medicine, and McKenzie-Willamette Hospital. A new three year contract was awarded to McKenzie-Willamette, which expired on December 31, 2001. PeaceHealth no longer provides these services.

On December 26, 2001, the Department issued a request for proposals, including legal advertisement in the Register-Guard. McKenzie-Willamette Hospital was the sole response to the solicitation. McKenzie-Willamette has provided excellent services to Public Works under the recently expired contract.

### B. Analysis

On October 19, 2004, the Department issued a request for proposals, including legal advertisement in the Register-Guard. The sole response was received from Cascade Health Solutions, formerly McKenzie-Willamette Hospital, Occupational Health.

Cascade Health Solutions will be opening a new facility located near the intersection of Coburg Road and Crescent Avenue on December 15, 2004. This location will be more convenient to the majority of employees with Commercial Drivers Licenses (CDL) requiring the requested services.

All positive and negative drug test results must be reviewed by a Medical Review Officer (MRO) before being released to the County. When summer help employees are hired the turn around time is often critical. Pre-employment drug test results are often needed within 24-hours. If the MRO is not available for review, the County's hiring process could be delayed. Cascade Health Solutions has four (4) physicians possessing the MRO certification.

The staff at Cascade Health Solutions includes eighteen (18) employees certified to perform alcohol evidential breath analysis testing and twenty-three (23) employees certified to collect drug test specimens.

Cascade's estimated cost of annual services is \$17,000.

## C. Alternatives/Options

 Purchase the required services from Cascade Health Solutions. There is no other option since alcohol and drug testing and CDL physicals are mandated by Federal law. Cascade Health Solutions was the only respondent to the County's request for proposal, and the only major provider of these services in Lane County.

### D. Recommendation

Award a three-year requirements contract to Cascade Medical Solutions.
