I. MOTION

TO RATIFY THE COUNTY ADMINISTRATOR'S EXECUTION OF TWO GRANT APPLICATIONS TO THE DEPARTMENT OF STATE POLICE, CRIMINAL JUSTICE SERVICES DIVISION FOR HOMELAND SECURITY INITIATIVES TOTALLING \$8,311,207, AND WHICH EXCEEDS THE BOARD'S ORIGINAL AUTHORIZATION OF \$7,000,000 (BOARD ORDER 04-2-25-6) BY \$1,311,207.

II. ISSUE OR PROBLEM

The Lane County Sheriff's Office received a proposal to respond to a request for grant application from the Department of State Police, Criminal Justice Services Division to support Homeland Security initiatives countywide. The initial estimate for the proposal request was \$7,000,000 for a period of 18 months beginning April 2004 through October 2005. The Board of Commissioners signed Board Order 04-22-25-26 authorizing the County Administrator to sign the grant application, but, at that time, the grant application was still a work in progress and detailed information about the exact dollar amount to be requested had not yet been determined. Through the grant writing process an opportunity was identified that allows jurisdictions to submit two grant applications, one that is specific to the needs of law enforcement (\$750,100) and another to represent the needs of all other disciplines (\$7,561,107). While the Board of Commissioners did approve a \$7,000,000 grant application, the County Administrator actually executed two applications which exceeded the preauthorized \$7,000,000 by an additional \$1,311,207 (or \$750,100 + \$561,107). The additional application and additional sum requested exceeds the County Administrator's signature authority, and accordingly the Board is asked to ratify the County Administrator's past action.

III. DISCUSSION

A. Background

The Department of State Police, Criminal Justice Services Division has released a request for grant proposals to implement a State Homeland Security Program to significantly enhance the ability of local agencies to prevent, deter, respond to and recover from threats and incidents of terrorism. The state is strongly encouraging collaborative, regional, multi-jurisdictional or other coordinated response to the grant application. As such, there has been widespread multi-
