1. MOTION: I MOVE TO ACCEPT THE CASH DEPOSIT AS SECURITY FOR THE

COSTS OF DISSOLUTION, FILE THE PETITION FOR DISSOLUATION OF

THE HAZELDELL RURAL FIRE DISTSRICT. AND REFER THE MATTER

TO THE DISTRICT FOR FURTHER PROCEEDINGS

II. ISSUE OR PROBLEM:

The citizens in the Oakridge/Westfir area have circulated a petition to initiate dissolution proceedings of the Hazeldell Rural Fire District, formed in 2002. The County needs to set the amount of the cash deposit to cover the costs of dissolution, file the petition, and refer the matter to the District for further proceedings in accordance with statutory requirements.

Ш. DISCUSSION:

A. Background. Citizens in Oakridge/Westfir area voted on and formed the Hazeldell Rural Fire District in 2002. However, a number of citizens have not been pleased with that result. A petition has been circulated requesting dissolution of the District. The petitioners have obtained sufficient valid signatures to initiate the statutory dissolution process, and have deposited the required deposit to cover the costs, if the County costs if the attempted dissolution is not successful.

B. Analysis. ORS Ch. 198 provides that a petition may be circulated to initiate dissolution proceedings of a special district, in this case, a rural fire protection district under ORS Ch. 478. Before the petition is formally accepted for filing, it must be accompanied by a bond or other deposit in an amount approved by the Board, not to exceed \$100 per precinct. The deposit is to insure the County will be paid the costs of the attempted dissolution in the event it is unsuccessful. It if is successful, the district pays the costs. ORS 198,775. The petitioners have tendered \$100 (there is only one precinct) and a statement indicating they will pay the excess costs, complying with ORS 198.775(1)(b).

The Chief Deputy County Clerk has certified that the petitioners have collected sufficient valid signatures to meet the statutory requirements. The statutes call for the Board to approve the security deposit, and accept the petition for filing. Then they require that, within 5 days of the filing, a copy of the petition be filed with the District secretary or any other district officer. who can, with reasonable diligence, be located. ORS 198.920(4).

The District has 30 days after the Board Order to file Findings of Fact and a Proposed Plan of Dissolution with the County Clerk. ORS 198.925. Then, within 10 days of filing the Plan, the District must file the necessary documents, including the filing fee, to initiate dissolution with the Boundary Commission. ORS 198.935. Ultimately, if the Boundary Commission approves the dissolution, the District Board must call for an election on the question. ORS 198.935.

C. <u>Alternatives/Options</u>. By statute, if sufficient signatures are certified and the security deposit is reasonable, the dissolution process must be commenced by the Board of Commissioners. And once that is done, the statutes impose mandatory obligations upon the District to file the Dissolution Plan, and commence the Boundary Commission process. In other words, these statutory duties are appear to be ministerial, and without the opportunities for the Commissioners to exercise options.

Should the District fail to comply with its statutory duties, the County may be faced with the issue of whether it wishes to pursue remedies with respect to the District, or whether it would look to the petitioners to do so.

- D. <u>Recommendations</u>. I recommend the Board accept the petition and deposit for filing and refer the matter to the District.
- IV. IMPLEMENTATION/FOLLOW-UP: Within 5 days of adoption of the Order, County Counsel will deliver copies of the order and petition to the District.

ORDERED that:

- 1. The security deposit in the form of a check for \$100 is hereby approved.
- 2. The petition to dissolve the district is hereby filed.
- 3. Within 5 days of this date, a copy of the petition shall be filed with the secretary of the Hazeldell Rural Fire District.
- 4. Within 30 days of this date, the Hazeldell Rural Fire District shall file with the Chief Deputy County Clerk findings of fact and a proposed plan of dissolution and liquidation, consistent with ORS 198,925 and ORS 198,935.
- 5. Pursuant to ORS 198.935(1), within 10 days after filing the plan of dissolution, the Hazeldell Rural Fire District shall file the required documents initiating dissolution with the Lane County Boundary Commission in accordance with ORS 199.476.
