**WHEREAS**, the said chairman has recommended that said parcel be released and dedicated for road purposes; now, therefore, it is hereby

**ORDERED**, that the Real Estate as described in the attached Dedication and depicted on the attached map be, and is hereby, Released, Dedicated and Accepted as Public Road right-of-way; and it is further

**ORDERED**, that the above Order be entered into the records of the Board of County Commissioner's Journal of Administration and further that the attached Dedication be recorded in the Lane County Oregon Deed Records, and the document number be noted on this Order.

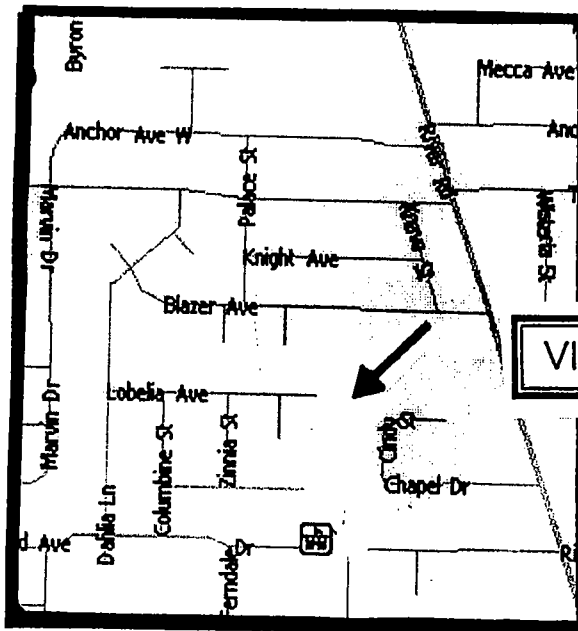
