**WHEREAS**, the said chairman has recommended that said parcel be released and dedicated for road purposes; now, therefore, it is hereby

**ORDERED**, that the Real Estate as described in the attached Dedication and depicted on the attached map be, and is hereby, Released, Dedicated and Accepted as Public Road right-of-way; and it is further

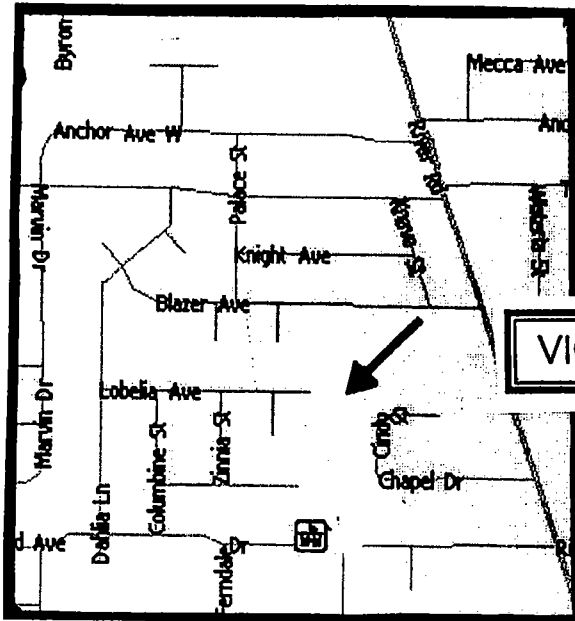
