Farmers Union, Inc. owns property located at 182 West 5th Street, Eugene, Oregon.

This property had two historic designation applications. For the 2004-2005 fiscal tax year both historic designations were removed and the value for this property was consolidated with the values for account numbers 0259732 and 0259398. It has since been determined that the historic designations should be reinstated on this portion of the property. The value has now been adjusted and the tax amount reduced resulting in a refund.

In October 2004, the Department of Assessment and Taxation sent a tax statement for the fiscal year 2004-2005 to the owner of record for the property, Farmers Union, Inc. The taxpayer sent in the full amount due with discount of \$20,702.40 on November 15, 2004. The payment was processed by the Department of Assessment and Taxation on November 30, 2004.

Due to the above circumstances, the Department needs to refund per Oregon Revised Statute 311.806(d) the tax amount of \$14,882.70 plus statutory interest through April 15, 2005, in the amount of \$744.14 for a total of \$15,626.84 to the owner of record, Farmers Union, Inc.
