I. **INFORMATIONAL REPORT**

THE ADDITIONAL INFORMATION PRESENTED IN THIS REPORT IS TO CLARIFY REST LAWN MEMORIAL PARK CEMETERY'S PROXIMITY TO THE ACQUISITIONS OF ADDITIONAL RIGHT OF WAY FOR COUNTY ROAD NO.'S 283 & 2080.

П. **BACKGROUND**

Information

The Public Work's road improvement project for High Pass Road and River Road is complete. Acceptance of deed right of way is the final step in this process.

Analysis

Rest Lawn Memorial Park Cemetery is located on tax map 15-04-31.43, as part of tax lot 8700 (See Tax Map Attachment B). Approximately 17 feet of the cemetery is within High Pass Road (See email dated July 14, 2000 and Attachment C Record of Survey, CSF 26311 Attachment D). The Cemetery is located on the north side of High Pass Road, roughly 0.5 miles east of the intersection of Highway 99 and the area of the acquisitions (See Vicinity Map Attachment A and GIS/Aerial map Attachment E).

The Vicinity Map, Attachment A, shows the area of road acquisition and its proximity to the cemetery. The cemetery is approximately 0.5 miles east of the acquisitions made for the road project as resolved and Ordered in Board Order No. 02-7-17-8.

III. RECOMMENDATION





Hi Betty,

I don't have a good answer for you on the ownership of this cemetery. The deeds for tax lot 8700 (going back 80 or 90 years) except out 1/3 of an acre for the cemetery, but I can't put my hands on a document to show who actually owns it.

The cemetery is identified in ODOT's 1977 "Oregon Cemetery Survey" as:

Rest Lawn Memorial Park Junction City aka Jct. City IOOF

I checked with Jeff Turk (Real Property Officer) and it does not show up on his inventory of county owned land.

The cemetery was surveyed by the City of Junction City in 1983. The survey shows a 17 foot encroachment of the fenced cemetery property (including burial plots) into the High Pass Road right of way.

If we had an approximate date that Steven Wright conveyed it to lane County we might be able to find it in the deed records. Otherwise you would have to have someone go back on the chain of title for you until they find a deed description that includes it. Someone has to own it. I'm sure a title company could sort it out for you.




