I. MOTION

MOVE TO AWARD A CONTRACT TO PAPE' MACHINERY, INC., IN THE AMOUNT OF \$620,262.00 FOR THE PURCHASE OF TWO (2) NEW, DIESEL POWERED TELESCOPING BOOM EXCAVATORS. AS SPECIFIED IN CONTRACT FY06/07 FS-08.

II. ISSUE OR PROBLEM

Shall Lane County approve awarding a contract to Pape' Machinery, Inc., for the purchase of Two (2), new Diesel-Powered Telescoping Boom Excavators, required by Public Works Engineering Division, as per established replacement criteria?

III. BACKGROUND/IMPLICATIONS OF ACTION

A. Board Action and Other History

Lane County Department of Public Works Engineering Division operates six (6) Diesel-Powered Telescoping Boom Excavators, two (2) of which have reached the end of their economic life and require replacement. Telescoping Boom Excavators are used for ditch cleaning, material handling and excavation projects throughout the County. These machines have a scheduled lifecycle of 12-years or 6,000 hours.

B. Policy Issues

None

C. Board Goals

Purchase of this equipment is necessary to provide direct and indirect services to the citizens of Lane County, to maintain satisfactory operations of the County's road system, and to meet the health, safety, and economic good of the citizens and industries of our community as defined in Section B3.a.2 of the Strategic Plan.

D. Financial and/or Resource Considerations

This equipment was approved for purchase in the Fleet Services FY06/07 budget, sufficient funds are available for this purchase, and the price is within the budgeted amount.

E. Analysis

The County received two (2) responses from its invitation to bid. The low bid of \$620,262.00, with two (2) trade-ins, was submitted by Pape' Machinery, Inc., with one (1) minor acceptable deviation from the published specifications.

F. Alternatives/Options

- 1. Purchase the above described equipment from Pape' Machinery, Inc., at this time.
- 2. Do not purchase at this time. The existing Diesel-Powered Telescoping Boom Excavators have been in service more than 14-years, and operated more than 8,000 hours. If not replaced, the machines will require a major overhaul of the powertrain and hydraulic systems. Estimated downtime for this work is 4-weeks at a cost that exceeds the value of the machines. Additionally, replacement service parts for older equipment units are often difficult to locate, resulting in unacceptable equipment downtime.

IV. <u>Timing/implementation</u>

Upon approval of the Board, a contract will be executed between Pape' Machinery, Inc., and the County Administrator.

V. Recommendation

It is recommended that the Board approve entering into a contract with Pape' Machinery, Inc., for the purchase of two (2) new, Diesel-Powered Telescoping Boom Excavators as specified in FY06/07 FS-08.
