Measure 37 claim to be heard.

### **PUBLIC HEARINGS/ MEASURE 37 CLAIMS**

All claims set for consideration by the Board are listed in Table 1 and will be reviewed together in a single, day-long proceeding. Two claims will be open public hearings. These hearings will allow anyone the opportunity to speak to any claim during public testimony and/or submit written testimony. Anyone who submits testimony will be sent notice of subsequent land use applications that rely on the Ballot Measure 37 claim. The Board may elect to adopt all or a subset of the provided draft orders in one motion. Any of the claims with issues can be removed and discussed by the Board in separate actions. Six claims are scheduled for deliberation only because they have already had a public hearing and the record has now closed. New testimony will not be allowed for claims with a closed record, unless the board re-opens them for a public hearing. Two claims received preliminary approval at the June 20, 2007 public hearing and have been placed on the Wednesday consent calendar for final approval.

### **Hearing Process**

The order of testimony for each claim listed for hearing in Table 1 will be as follows:

- 1. Applicant.
- 2. Others.
- 3. Rebuttal by applicant.
- 4. Questions from the Board, if necessary.

After closing or continuing the hearings on the listed claims, the Board may:

- 1. Identify claims for further discussion.
- 2. Act on those not requiring more discussion (by number from Table 1).

### Possible Motions following the Hearings

- 1. Motion for Board to adopt the proposed orders for the claims that appear valid.
- 2. Motion for Board on individual orders or claims pulled for discussion.
- 3. Motion that remaining claims have inadequate information to determine their validity and direct the County Administrator to issue letters of denial.

### **ANALYSIS AND RECOMMENDATIONS**

There are ten claims scheduled for Board action. Two of the claims are scheduled for a public hearing, they are Babb and VanDuyn. Two claims received tentative approval at the June 20, 2007 public hearing and have been placed on the Wednesday consent calendar, they are Robinson and Warner. The record closed on June 29, 2007 for the remaining six claims that are scheduled for Board deliberation only, they are Bixler, Brandt, Larsen, Montgomery, Petersdorf and Shelley.

There are two claims recommended for denial, they are Larsen and Shelley. Refer to the staff reports for those claims for further details. If the Board concurs with the recommendations, the County Administrator will issue a letter to that effect for each claim. The remaining claims appear valid as described in the attached reports and the County Administrator recommends the Board adopt the proposed orders for those claims.
