II. **DISCUSSION**

A. Background/Analysis

Board Order 04-2-25-5 authorized award of bid LCP 2003-08 to Diamond Pharmacy Services for requirements purchase of pharmacy services for Lane County Adult Corrections, and authorized execution of a three-year contract.

The term of the contract began 1 April 2004 and will end 31 March 2007. Amendment 1 extends the contract through 30 September 2007.

Lane County Adult Corrections needs a six-month extension of the current contract at the current pricing levels while the Oregon Jail Manager's Association works on a state-wide inmate pharmacy contract with the hope of realizing lower pharmacy prices based on a larger pool of contract users.

The extension will also provide Lane County Adult Corrections time to complete their own Request for Proposal should the Jail Manager's Association decide to not go forward with a state contract.

The estimated cost of the three-year base contract was \$950,000. To date, the total cost of the contract has been lower than expected and therefore the amendment will not increase the contract amount.

A request to waive competitive selection for a six-month extension to the Inmate Pharmacy Services Contract with Diamond Pharmacy Services has been approved by the County Administrator in accordance with Lane Manual 21.118 (9) (c).

B. RECOMMENDATION

Staff recommends approving execution of Amendment 1 to the Inmate Pharmacy Services Contract.

Lane County should take advantage of the possibility of obtaining inmate pharmacy services at a lower price.
