WHEREAS, projects shown on the list of public improvements, attached hereto as Exhibit 'A', has been proposed by County Departments for funding during FY 07/08; and

WHEREAS, each project, to be funded, must be included in an adopted Capital Improvement Program and/or identified in the FY 07/08 budget; and

WHEREAS, inclusion of a project in the list of public improvements, Exhibit 'A', does not obligate the County to fund that project in FY 07/08; **NOW THEREFORE, BE IT**

ORDERED, that the list of FY 07/08 public improvements, attached hereto as Exhibit 'A', be filed with the Commissioner of the Bureau of Labor and Industries, in compliance with ORS 279C.305.
