DISCUSSION

Background/Analysis A.

Lane County Sheriff's Office is in receipt of a Lane County Circuit Court judgment, Case Number 20-05-24783, dated 15 June 2006, which ordered that Parcel 2 be forfeited to the Lane County Sheriff, with 50% of the final proceeds after sale to be returned to the Defendant or his designees.

The judgment further ordered that the sale of the property be accomplished by any reasonable manner determined by the Lane County Sheriff.

Parcel 2 is Assessor's Map No. 19-12-271300100 located at 83343 N. Pioneer Rd., Florence, Oregon.

Property is 0.73 acres and assessed a value of \$128,752.

The Lane County Sheriff's Office wishes to list the property with a realtor to insure maximum exposure, and receive the maximum fair price of the property. A selection process pursuant to Lane Manual is being used to choose a realtor.

The property will be sold "as is" with no warranties or guaranties as to its ability to be used for any purpose or condition of title.

ORS 275.030(2), covering county lands, suggests that in cases other than foreclosures for nonpayment of real property taxes, and when the county governing body deems it not to be in the best interest of the county to sell and convey by auction, the county may sell by private sale.

ORS 271.310(1) provides for selling, exchanging or leasing county property if the property is no longer needed for public use or if the public interest can be furthered by a sale.

Offers received for the property will be forwarded under Board Order for acceptance or rejection by the Board of County Commissioners.

B. RECOMMENDATION

Staff recommends approving the private sale of forfeited county owned real property identified as Assessor's Map No. 19-12-271300100.

Private sale of forfeited real property is more likely to generate a higher value over a Sheriff's Office auction of the property.


