ORDER NO.

THIS MATTER now coming before the Board of County Commissioners of Lane County and Paul M. Oestreich, owning land within Lane County which is not within the limits of an incorporated city or town, having on this day presented to the Board of County Commissioners of Lane County a good and sufficient deed, said deed being properly executed and forever dedicating a portion of such land to the use of the public for road purposes and granting a public road easement, and the Board of County Commissioners of Lane County deeming it proper, as a convenience for property owners in the area and as a benefit to the general public, to accept said deed for a public road easement;

NOW, THEREFORE, IT IS HEREBY ORDERED that the said deed shall be and is hereby accepted by the Board of County Commissioners of Lane County as a public road easement and not as a county road; and

IT IS FURTHER ORDERED that the above Order shall be entered in the records of the Board of County Commissioners' Journal of Administration, Lane County, Oregon; and

IT IS FURTHER ORDERED that the deed be recorded in the Deed Records of the County and the Instrument Number be noted on this Order.

DEDICATION OF A PUBLIC ROAD EASEMENT**PAUL M. OESTREICH**

GRANTOR, grants and dedicates to LANE COUNTY, a political subdivision of the State of Oregon (**GRANTEE**) a public road easement on and over the following described property:

A parcel of land lying in the Northwest One Quarter (NW ¼) of the Southwest One Quarter (SW ¼) of Section 23, Township 17 South, Range 1 West of the Willamette Meridian, and being a portion of the tract of land conveyed to Paul M. Oestreich by that certain Personal Representative's Deed recorded on October 23, 1986 on Reel 1426R, Recorder's Reception Number 8642346 as a correction to that Personal Representative's Deed recorded on September 18, 1986 on Reel 1420R, Recorder's Reception Number 8636201, Lane County, Oregon, Deed Records, said parcel being more particularly described as follows:

Beginning at the Southwest corner of the Southeast One Quarter (SE ¼) of the Northwest One Quarter (NW ¼) of Section 23, Township 17 South, Range 1 West of the Willamette Meridian; thence North 0°06'55" West 346.91 feet to a point; thence South 89°53'05" West 60.00 feet to a point on the westerly right of way of Latta Road as established by deed recorded May 23, 1966, Reel 288-D, Instrument No. 48310; thence following said westerly right of way of Latta Road South 0°06'55" East 463.91 feet to the TRUE POINT OF BEGINNING of this dedication; thence South 89°53'05" West 35.00 feet to a point; thence South 0°06'55" East 20.00 feet to a point; thence North 89°53'05" East 35.00 feet to a point on said westerly right of way of Latta Road; thence North 0°06'55" West 20.00 feet to the True Point of Beginning, all in the Northwest One Quarter (NW ¼) of the Southwest One Quarter (SW ¼) of Section 23, Township 17 South, Range 1 West of the Willamette Meridian, Lane County, Oregon.

The bearings and distances herein are based upon the deed from Jacob H. Koch, Paul L. Oestreich and Arlette Oestreich to Lane County for road purposes recorded May 23, 1966, Reel 288-D, recorder's reception number 48310.

It being the intent herein to acquire right-of-way for Latta Road, a public road which, with this dedication, will result in a right-of-way of 65 feet width from centerline as said road abuts the GRANTOR'S property.

There is no consideration for this dedication.

Said parcel being forever dedicated to the use of the public for road purposes and granting a public road easement.
