#### I. MOTION

To approve the Order to amend Final Order Number 07-7-11-11, in the matter of establishing a timeline for delivery of signed dedications for Bob Straub Parkway, Phase II

### II. <u>DISCUSSION</u>

#### A. Background / Analysis

On July 11, 2007 the Lane County Board of Commissioners approved Order No. 07-7-11-11 regarding the dedication and acceptance of right of way for the Bob Straub Parkway, Phase II. This Order established a timeline for delivery of signed dedications and authorized their formal acceptance as county road right of way.

The signed dedications were delivered to the County Administrator of Lane County prior to the specified deadline and said Order No. 07-7-11-11 was approved with reference to the right of way described in the dedications being expressly accepted as a portion of County Road Number 2555 (Bob Straub Parkway).

References in said Order to County Road Number 2555 were incorrect and instead should have been to County Road Number 2255. This Amended Order is intended to correct Order No. 07-7-11-11, so that all references to County Road Number 2555 are changed to County Road Number 2255.

#### B. Recommendation

It is recommended that the Board of County Commissioners approve the Order to Amend as submitted. This action will amend references to an incorrect county road number in Order 07-7-11-11 as previously approved.
