### II. DISCUSSION

### A. Background / Analysis

ShelterCare was the sole respondent to a Letter of Intent (LOI) to bid on permanent supported housing services for chronically homeless adults with severe and persistent mental illness (SPMI). The letter of intent was for the period February 1, 2007 through January 31, 2009 with the ability to be extended for one additional year. The LOI indicated funding in the amount of \$187,248 per year. This contract amendment is for the period February 1, 2008 through January 31, 2009, which is within the period described in the LOI. These funds were allocated as part of Health & Human Service's original budget.

## **Recommendation**

Lane County Health & Human Services recommends approval of the amendment with ShelterCare for permanent supported housing services for chronically homeless adults with severe and persistent mental illness.
