WHEREAS, the U.S. Forest Service and the Bureau of Land Management have established procurement procedures for the award of Title II funds; and

WHEREAS, authorized signatures are required to receive these funds; and

WHEREAS, seven projects were approved by four different Resource Advisory Committees to provide Title II funds for the Lane County Forest Work Camp and the Juvenile Forest Work Team projects; and

WHEREAS, Board approval is required for awards over \$100,000 and three of the approved projects exceed this amount; and

WHEREAS, the award of Title II funds is required to fully fund two approved Title III county projects; and

WHEREAS, the Board has previously approved similar signing authority for federal assistance agreements under Title II in FY02-FY07 (Board Orders 02-5-15-1, 03-01-15-2, 04-3-31-6, 05-3-16-6, 06-3-15-11, and 07-5-23-10):

NOW, THEREFORE, it is hereby ordered:

1. The Board approves the Federal Financial Assistance Award from the Willamette National Forest not to exceed \$358,387 in Title II funds for the Forest Work Camp.
2. The Board approves the Federal Financial Assistance Award from the Siuslaw National Forest not to exceed \$108,270 in Title II funds for the Forest Work Camp.
3. The Board approves the Federal Financial Assistance Award from the Rogue/Umpqua National Forest not to exceed \$73,156 in Title II funds for the Forest Work Camp.
4. The Board approves the Federal Financial Assistance Award from the Eugene Bureau of Land Management (BLM) not to exceed \$244,834 in Title II funds for the Forest Work Camp.

5. The Board approves the Federal Financial Assistance Award from the Eugene Bureau of Land Management not to exceed \$87,595 in Title II funds for the Department of Youth Services Juvenile Forest Work Team.
6. The Board approves the Federal Financial Assistance Award from the Willamette National Forest not to exceed \$48,000 in Title II funds for the Juvenile Forest Work Team.
7. The Board approves the Federal Financial Assistance Award from the Siuslaw National Forest not to exceed \$17,519 in Title II funds for the Juvenile Forest Work Team.
8. The County Administrator is authorized to sign the Federal Financial Assistance Agreements for Title II funds for FY 07-08 along with the follow-up task orders, agreements, certifications and assurances issued by the Eugene BLM and the U. S. Forest Service for work to be performed under the above awards.
