I. MOTION

I MOVE THAT THE BOARD APPROVE THE REPRESENTATIVES AND DESIGNEES TO VARIOUS COMMITTEES AND AGENCIES AS OUTLINED IN THE PROPOSED ORDER.

II. AGENDA ITEM SUMMARY

The Board is being asked to approve representatives and designees to various agencies and committees for the remainder of 2009.

III. BACKGROUND/IMPLICATIONS OF ACTION

A. Board Action and Other History

The Board passed a Good Governance order in January of 2009. The order restructured how and when commissioners would be assigned as representatives to committees and agencies. Unless such an assignment was required by law, the Order provided for the County Administrator to be designated as the representative.

B. Board Goals These revisions are consistent with the Board's goals as outlined in the Good Governance Order.

C. Financial and/or Resource Considerations

The revisions will place an extremely large workload on the County Administrator, both with his assignments under this proposed order, and the accompanying order appointing liaisons.

D. Analysis

The proposed order accomplishes the Board's goals yet allows the County to still participate on the various agencies and committees through it's designee. There are committees and agencies where the participation of a Commissioner, or more than one, is required either under state law or through an Inter-governmental agreement. Those committees and agencies are:

Council of Forest Trust Land Counties, the Association of O & C (AOC) Counties, the Oregon Coastal Zone Management Association, the Human Services Commission (requires that one of two representatives be an elected official), the Lane Economic Committee (LEC), LRAPA, the Lane Council of Government (LCOG) Board of Directors, the Public Safety Coordinating Council (requires 1 Commissioner rather than the historic 2 that were appointed), the Metropolitan Policy Committee (MPC), the Housing Policy

Board, Lane Metro Partnership (LMP) Board of Directors, the Lane Workforce Partnership Advisory Committee, and the Metropolitan Wastewater Management Commission (MWMC).

F. Alternatives/Options

The Board could choose to approve the Board Order, or to assign Commissioners to some of the agencies and committees that have historically had a commissioner as the representative for Lane County.

IV. TIMING/IMPLEMENTATION

Effective immediately upon approval.

V. RECOMMENDATION

I recommend the Board adopt the proposed changes.
