II. DISCUSSION

A. Background/Analysis

The Lane County Animal Services Advisory Committee (LCASAC) was created as a part of BO# 07-10-31-10 and Lane Manual was updated to include the LCASAC via BO# 07-12-12-05.

The membership of the committee includes a designee appointed by each of the County Commissioners and two at-large members. Commissioner designees were appointed as part of the creation of the LCASAC. The at-large members were appointed through BO# 08-01-08-02.

Commissioner Stewart's designee's term has expired. Commissioner Stewart has selected his replacement who must now be appointed through a Board action. Commissioner Stewart's designee is Cary Lieberman, Director of Greenhill Humane Society. Cary Lieberman had previously been appointed to the committee as Commissioner Green's designee, but as Commissioner Green is no longer with the Board of County Commissioners, Mr. Lieberman is no longer on the committee as his designee.

B. Recommendation

Staff recommends that the Board re-appoint Cary Lieberman to the Lane County Animal Services Advisory Committee as Commissioner Stewart's designee.
