# II. <u>DISCUSSION</u>

### A. Background / Analysis

This agenda item meets the abbreviated consent calendar criteria because it is delegating contract signature authority to the County Administrator for two contracts awarded through a state competitive process and funded through state programs.

Gateway Living has been awarded funds through a State of Oregon competitive process (State of Oregon Letter of Interest #1338) to provide a Residential Treatment Facility for the mentally ill in Lane County. Funds are awarded through Amendment #80 to the County Intergovernmental Agreement. Funds include start up costs, rent subsidy and service payment for a total amount of \$217,847 for the period January 1, 2009 through June 30 2009.

Cascadia Behavioral Healthcare has been awarded funds through a State of Oregon competitive process (State of Oregon Letter of Interest # 1337&1342) to provide outpatient mental health services at the Gateway Living Residential Treatment Facility. Funds are awarded through Amendment #80 to the County Intergovernmental Agreement. Funds include start up costs and adult treatment services for a total amount of \$311,739.

## B. Recommendation

To approve the motion stated above and delegate contract signature authority to the County Administrator for two contracts funded by state programs; Gateway Living in the amount of \$217,847 and Cascadia Behavioral Healthcare in the amount of \$311,739 for the period January 1, 2009 through June 30, 2009.
