) LABOR AND INDUSTRIES (BOLI)

WHEREAS, ORS 279C.305 requires that not less than thirty (30) days prior to the adoption of a budget, each public agency must: (1) Prepare and file with the Commissioner of the Bureau of Labor and Industries a list of each public improvement known to the agency that it plans to fund during the budget period; (2) Identify each improvement by name and estimate of the total on-site construction costs; and (3) List whether that project is to be bid out to a private contractor or to be performed by Lane County;

WHEREAS, projects estimated to cost more than \$125,000 will conform to the requirements of ORS 279C.305 and will be constructed at the least cost to the public agency;

WHEREAS, projects shown on the list of public improvements, attached hereto as Exhibit 'A', have been proposed by County Departments for funding during FY09/10; and

WHEREAS, each project, to be funded, must be included in an adopted Capital Improvement Program and/or identified in the FY09/10 budget; and

WHEREAS, inclusion of a project in the list of public improvements, Exhibit 'A', does not obligate the County to fund that project in FY09/10; **NOW THEREFORE, BE IT**

ORDERED, that the list of FY09/10 public improvements, attached hereto as Exhibit 'A', be filed with the Commissioner of the Bureau of Labor and Industries, in compliance with ORS 279C.305.
