**I. MOTION**

Move approval of the Board Order in order to file with the Commissioner of Bureau of Labor and Industries a list of each public improvement that the county plans to fund during the budget period per ORS 279C.305 and to authorize the County Administrator to execute all agreements in connection with the Public Improvements Projects Identified on Exhibit 'A'.

**II. DISCUSSION**

**A. Background / Analysis**

Lane County is to report its public improvement projects to the Commissioner of Bureau of Labor and Industries (BOLI) on an annual basis as required by ORS 279C.305. This requirement is for capital improvement projects that we anticipate bidding out.

ORS 279C.305 requires that not less than thirty (30) days prior to the adoption of a budget, each public agency must: (1) Prepare and file with the Commissioner of the Bureau of Labor and Industries (BOLI) a list of each public improvement known to the agency that it plans to fund during the budget period; (2) Identify each improvement by name and estimate of the total on-site construction costs; and (3) List whether that project is to be bid out to a private contractor.

**B. Recommendation**

To approve the motion stated above, allowing the public improvement projects to be filed with the Commissioner of Bureau of Labor and Industries.

WHEREAS, projects shown on the list of public improvements, attached hereto as Exhibit 'A', has been proposed by County Departments for funding during FY 09/10; and


WHEREAS, each project, to be funded, must be included in an adopted Capital Improvement Program and/or identified in the FY 09/10 budget; and

**ORDERED**, that the list of FY 09/10 public improvements, attached hereto as Exhibit 'A', be filed with the Commissioner of the Bureau of Labor and Industries, in compliance with ORS 279C.305.
