### I. MOTION

In the Matter of Appointing Designees of the Community Mental Health Director to Direct a Peace Officer to Take a Mentally Ill Individual into Custody According to ORS 426.233

### II. ISSUE OR PROBLEM

The peace officer hold statute (ORS 426.233), as amended by the 1997 Legislative Assembly, permits a Community Mental Health Director, or his/her designee, to direct a peace officer to take an allegedly mentally ill person who the director or his/her designees has probable cause to believe is dangerous to self or any other person and who the director or designee has probable cause to believe is in need of immediate care, custody or treatment of mental illness into custody. The law states that a designee must be recommended by the Community Mental Health Director, and be approved by the county governing body before assuming the authority permitted under this statute.

### III. DISCUSSION

#### A. Background / Analysis

Oregon Revised Statute 426.233, as amended by the 1997 Legislative Assembly, permits the local Community Mental Health Director or his/her designees to direct a peace officer to take into custody a person who the Director or designee has probable cause to believe is in need of immediate care, custody or treatment for mental illness. This authorization is valid for the term of employment as a Mental Health Specialist with Lane County, or until the designation: is removed upon the recommendation of the Community Mental Health Director and approval of the Board of County Commissioners.

Board Order 08-12-10-5 appointed designees to perform this function. Since this last Board Order, personnel changes at Lane County Mental Health require that an updated list of designees be appointed. Facility Mental Health Agreements Emergency Authorization were executed on 11/3/2009 by Cascadia Behavioral Health Care and ShelterCare.

Below is a complete list of current Lane County Mental Health employees and Lane County Sheriff Department employees and employees of Cascadia Behavioral Health Care and ShelterCare that are recommended to be appointed designees by the Community Mental Health Director.

The ability of the Community Mental Health Director or his designee to place an allegedly mentally ill person on a hold has, and can, save the individual and the community from the negative consequences of acts conducted while an individual is actively mentally ill and dangerous to themselves or others.

**B. Alternatives / Options**

1. Approve the Community Mental Health Director's recommended designees to use the authority provided in ORS 426.233.
2. Do not approve the Community Mental Health Director's recommended designees to use the authority provided in ORS 426.233.

**C. Recommendation**

It is recommended that the Board of County Commissioners approve the Community Mental Health Director's designees.

**IV. IMPLEMENTATION**

With approval of the Board, all Lane County law enforcement agencies will be notified of the current list of designees and the Director's designees will exercise the authority granted by statute.

WHEREAS, Lane County regards community safety as a high priority, and

WHEREAS, the 1997 Legislative Assembly amended ORS 426.233 to permit the local Community Mental Health Director or his/her designees to direct a peace officer to take an allegedly mentally ill individual into custody; and

WHEREAS, a designee must be recommended by the Community Mental Health Director and be approved by the county governing body; and

WHEREAS, Board Order 08-12-10-5 appointed designees to perform that function and since the last Board Order, personnel changes at Lane County Mental Health require that an updated list of designees be appointed.

WHEREAS, Lane County/Facility Mental Health Agreements Emergency Authorization were executed by Cascadia Behavioral Health and ShelterCare on 11/3/2009.

NOW, THEREFORE, IT IS HEREBY ORDERED that the Lane County Board of Commissioners authorize the updated list of Community Mental Health Director's designees operating under ORS 426.233 to direct peace officers to take into custody a person who the Director or his designee has probable cause to believe is in need of immediate care, custody or treatment for mental illness. This approval is valid for the term of employment or until recommended by the Community Mental Health Director and approved by the Board of County Commissioners to remove the designation.
